The advertiser agrees to reimburse Armstrong<sup>®</sup> Cable Services for all costs and expenses, including reasonable attorney fees and court costs, incurred in connection with exercise of its rights under this agreement. Armstrong<sup>®</sup> Cable Services reserves the right to revise or reject any advertisement believed to be false, misleading or objectionable.

Armstrong<sup>®</sup> Cable Services reserves the right to change the channel on which the advertisement will appear provided the advertisement is displayed on another channel.
